## **Approval of Minutes**

# Public Hearing for the proposed term change for the Highway Superintendent

The advertised public hearing of the Town of Starkey Board for the Town of Starkey, at the Starkey Town Hall, 40 Seneca Street, Dundee, Yates County, New York was called to order at 7:03 PM to consider changing the 2-year term for Highway Superintendent to a 4-year term by George Lawson, Supervisor. At this time George Lawson, Supervisor, opened the public hearing for discussion to the residents attending this meeting both in-person and virtually via Zoom.

#### **Discussion**

George reviewed that the board will vote on a resolution that is subject to a mandatory referendum on the election ballot. The resolution is to change the elected term of office from 2-years to 4-years.

## Public Hearing for proposed Local Law regarding Videoconferencing Technology

The advertised public hearing of the Town of Starkey Board for the Town of Starkey, at the Starkey Town Hall, 40 Seneca Street, Dundee, Yates County, New York was called to order at 7:04 PM to consider adopting "A Local Law authorizing the Public Bodies to use videoconferencing technology to participate in public meetings" in accordance with Open Meetings Law, § 103. At this time George Lawson, Supervisor, opened the public hearing for discussion to the residents attending this meeting both in-person and virtually via Zoom.

# Discussion

- This local law will allow for board members (for all public boards) to be able to attend via videoconferencing technology. George goes on to state that this would follow the protocol that has been set during the pandemic of 2020. However, there are more stipulations that are required with the passing of this local law.
  - Physical location attendance is required to count toward the quorum.
  - All meetings will require recording, and within 5 days, the link will need to be posted on the Town's website and remain available for a minimum of 5 years.
  - Transcription of the meeting must be able to be provided upon request.
- Candace states that she is concerned that these stipulations will absorb a large amount of time each month.
- The Board agrees that videoconferencing is a convenient way to allow applicants that reside outside of the area for the majority of the year to attend, however, board attendance at the physical location is needed.
