Section 1. Authority.

This Local Law is adopted pursuant to the provisions of section 10 of the Municipal Home Rule Law of the State of New York, Section 23 of the Town Law of the State of New York, and Section 3 of the Public Officers Law of the State of New York.

Section 2. Exemption of Residency Requirement for Appointed Officers.

The person or persons appointed to any Public position, in the Town of Starkey shall not be required to be an elector or resident of the Town of Starkey in order to hold and serve such position, but said person or persons must be a resident of the County of Yates or contiguous counties.

Section 3. Supersession.

This Local Law is intended to supersede and inconsistent authority, including Town Law 20 and 23 or Public Officers Law 3, To the extent such statutes establish eligibility for the Code Enforcement Officer, Assessor or any Public Officer within the Town of Starkey contingent upon residency within the jurisdictional limits of the Town of Starkey.

This Local Law shall take place upon filing with the Secretary of State as required by Municipal Home Rule Law.
