Townhall Cleaner

- George Lawson discussed that Candace Iszard, Town Clerk received notice from the Town Hall Cleaner, Ruth Martin that at the end of 2022 she would no longer be available to clean due to personal reasons. Candace went on to state that if we can find another cleaner that Ruth would be open to resigning earlier.
- Chelsey Chappell, Court Clerk, expressed interest in this position. George asked the board if there were any objections to hiring Chelsey. All are in favor.

Veteran Exemption

- George Lawson reviewed the proposed Local Law which would increase the maximum exemption limits for the Alternative Veteran's Exemption to twenty-four thousand (\$24,000), sixteen thousand (\$16,000), and eighty thousand dollars (\$80,000), respectively.

ARPA Funding

- Candace Iszard presented the Coronavirus State & Local Fiscal Recovery Funds: Overview of the Final Rule (January 2022) to the board highlighting that on page 11, "Spending on Government Services" outlines some examples of government services, and in the outline administrative facilities is listed, making the funds available for the repairs to the Town Hall.

The Village of Dundee would like to enter into a shared service agreement that would allow for the Town residents to dump brush at the Village location, and the Town would share in the tub grinding expense, but the Village would retain the mulch for use at their wastewater treatment plant.
