# **Approval of Minutes**

# Highway Report- Ralph Warren

- Ralph discussed that the 2015 International truck has returned from Wilbri following repairs. While this truck was in the shop, the Town of Starkey was able to borrow a truck from Yates County.
- The equipment trailer that was replaced in 2023, we have been trying to obtain a copy of the title, with no luck, George suggests advertising it for sale in the Observer, stating that it is not for road use. Ralph will get specs together for the ad.
- Julie Dunkelberger questions if the 2009 tractor and mower issues from last year have been rectified and remain in good working condition.
- Pick-up Truck, Ralph states that he would like to begin to get quotes on a new truck (4-door, with plow) with the expectation that the current 2019 Ford will become the work truck. He is expecting the quote to be \$70,000-\$80,000.
- Ralph plans to get a quote for tree work that is needed on Starkey Point Road prior to replacing the culvert. Goerge and Ralph discuss that as a result of the location of the culvert a temporary work easement will be needed and written permission from the property owners due to the location being outside of the Town's right of way. George states that he will work with the Town's attorney to draft the documents necessary.

# Agreement with the Town of Starkey for Bookkeeping Services

This agreement made December 29, 2023, by and between the Village of Dundee, 12 Union St. Dundee, New York, hereinafter referred to as "VILLAGE" and the Town of Starkey, 40 Seneca St. Dundee, New York, hereinafter referred to as the "TOWN".

WHEREAS, the General Municipal Cooperation Law, GML A1ticle 5G, authorizes local units of New York State to enter into a contract with any other local unit or units for the joint provision within their several jurisdictions of any service which any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the Village and Town have identified an area where working together through shared services will result in positive outcomes for both municipalities; and

WHEREAS, the Village and Town now wish to enter into a Shared Services Agreement for Bookkeeping and any related services; and

WHEREAS, the Village has agreed to provide the Town of Starkey with the services of its bookkeeper pursuant to the terms and conditions set forth in a Shared Services Agreement between the Village and Town.

WHEREAS, the Town shall pay to the Village for the services to be provided under this agreement, the sum of \$1,170 per month.

WHEREAS, the Town shall pay to the Village for the start-up administrative assistance \$500 per month for January and February 2024.

WHEREAS, This Agreement shall be effective from January sl t, 2024 through December 31st, 2024.

NOW, THEREFORE, BE IT RESOLVED the Village Board of trustees did hereby authorize and direct the Mayor to execute a shared service agreement with the Town of Starkey.
