

pursuant to the provisions of Article 17 of the General Municipal Law, the subject premises being situated in said Town of Starkey; and

WHEREAS, a public hearing was held jointly between the Board of Trustees of the Village of Dundee and the Town Board of the Town of Starkey, on October 4, 2018 at 7:00 p.m. at the Starkey Town Hall, 40 Seneca Street, Dundee, New York 14837 upon due notice having been given by publication and posting, together with a mailing of copies thereof to the Dundee Central School District and the Petitioner herein, as pertains to the Board of Trustees and the Town Board; and

WHEREAS, the Town Board has adopted a motion consenting to the Board of Trustees of the Village of Dundee acting as lead Agency for SEQR purposes; and

WHEREAS, discussion has been had by the Town Board regarding the issues of whether the Petition complies with Article 17 of the General Municipal Law and whether it is in the overall public interest to approve the annexation.

NOW THEREFORE BE IT RESOLVED, THAT

1. The Town Board determines that the Petition herein complies with the provision of Article 17 of the GML in that: it states the number of inhabitants of the territory proposed to be annexed; it describes the territory proposed to be annexed; is signed by the owner of 100% of the assessed valuation of the territory proposed to be annexed; a certified statement by the Assessor for the Town of Starkey to the territory proposed to be annexed is attached to the petition; the petition has been duly served upon the Clerk of the Village of Dundee, as well as, the Clerk of the Town of Starkey and the petitioner's signature thereon has been duly acknowledged.

2. The Town Board determines that it is in the overall public interest to approve the proposed annexation considering:

A. The effects on the territory to be annexed.

The annexation will permit that territory to be served by the Village water and sewer systems. The Village will also maintain the street known as Brown Blvd., upon the dedication thereof. Territory to be annexed is surrounded on all sides by territory of the Village of Dundee.

B. The effects upon the local government to which the territory is to be annexed.

The annexation of the subject territory will not have any negative effect on the Village. Any additional municipal services that may be required will not place any undue burden upon the municipal government. The territory will be added to the Village tax roll.

C. The effects upon the remaining territory of the municipality in which the territory proposed to be annexed is presently located.

The territory proposed to be annexed is 0.80 acre. The territory to be annexed will remain subject to Town taxation.

D. The effects upon the school district of the proposed annexation.

The territory proposed to be annexed is in the Dundee Central School District. Annexation will not result in any changes that will negatively affect the Dundee Central School District.

3. The Town Board hereby approves the proposed annexation and directs that certified copies hereof, subsequent to signature hereon by members of the Board of Trustees present at the Meeting at which this "Order, Resolution and Determination" was adopted, be filed with the Town Clerk of the Town of Starkey, and that such other actions as are necessary to implement and effectuate such annexation be carried out by the Town Supervisor and the Town Clerk.

4. In the event that there is any existing municipal debt on the part of the Town of Starkey applicable to the territory proposed to be annexed, such debt shall be apportioned for such territory and shall be a charge upon and be paid by the Village of Dundee pursuant to the provisions of §708 of the General Municipal Law.

5. Rights with respect to real or personal property pertaining to the territory to be annexed shall be disposed of pursuant to §707 of the General Municipal Law.

6. Any real property taxes and other charges against the territory proposed to be annexed shall be disposed of pursuant to §710 of the General Municipal Law.

7. In the event that the Board of Trustees of the Village of Dundee determines that it is not in the overall public interest to approve the proposed annexation, the Clerk shall file a certified copy of the "Order, Resolution and Determination" made by each of the Village of Dundee and the Town of Starkey with the

Yates County Clerk within ten (10) days of the filing of such "Order, Resolution and Determination" with the Clerk of the Village of Dundee.

She also confirms that the Yates Co. Treasurer is against it as well. Sue and Candace attended a meeting with the Yates Co. Treasurers' office to voice issues and concerns that we have with the NEW tax software. Bond Financial sent a Sexual Harassment Policy document for distribution to all employees by October 9th, 2018.
