George opened a town board member only discussion on their response to the public comments concerning the Local Law Establishing a Moratorium on Kennels.

RESOLUTION 4-2018 Local Law 1-2018

A local Law Establishing a Moratorium on Kennels in the Town of Starkey BE IT ENACTED by the Town Board of the Town of Starkey as follows:

Section I. STATEMENT OF LEGISLATIVE INTENT:

The present regulations on kennels in the Town of Starkey Zoning Regulations Local Law do not address the emergence of large-scale kennels and breeders. When unregulated or improperly regulated, these facilities can be detrimental to the health, safety and welfare of the dogs or other domestic animals in these kennels and to the public who work in, patronize, visit, conduct business with or otherwise come in contact with or feel the effects of such kennels and to the environment.

THEREFORE, it is the intention of the Town Board to enact a moratorium on the establishment, placement, relocation, construction, reconstruction, enlargement, modification or erection of kennels so that the Town Board can review the present Town, State and Federal laws and

regulations pertinent to kennels and have the opportunity to enact laws to better protect and preserve the health, safety and welfare of the dogs and other domestic animals in kennels, of the public who will work in, patronize, visit, conduct business with or otherwise come in contact with or feel the effects of such kennels and of the environment.

Section 2. DEFINITIONS

A. Town: Town of Starkey, Yates County, New York.

B. Town Board: Town of Starkey Town Board.C. Planning Board: Town of Starkey Planning Board.D. Zoning Board: Town of Starkey Zoning Board.

E. Building Inspector: Town of Starkey Building Inspector or Code Enforcement Officer.

F. Dog: Any member of the species canisfamiliaris, or as otherwise defined in the New York State Agriculture and Markets Law (section 108, as amended) or in the Federal Animal Welfare Act (7 U.S.C. 2131 et seq.).

G. Domestic Animal: Any animal customarily used or kept as a pet, including but not limited to a cat, rabbit, hamster, ferret or guinea pig, or as otherwise defined in the New York State Agriculture and Markets Law (section 108, as amended) or in the Federal Animal Welfare Act (7 U.S.C. 2131 et seq.).

H. Kennel: Any premises or structure used to breed, house, shelter, incarcerate, groom, train or offer for sale four (4) or more dogs or other domestic animals, other than farm animals, male or female, over the age of four months.

Section 3. MORATORIUM

A. The Town Board hereby enacts a moratorium that shall prohibit the establishment, placement, relocation, construction, reconstruction, enlargement, modification or erection of any kennel anywhere within the Town.

- B. This moratorium shall be in effect for a period of one (1) year from the effective date of this Local Law and shall expire on the earlier of (i) the date one (1) year from said effective date, unless renewed: or (ii) the enactment by the Town Board of a resolution indicating the Town Board is satisfied that the need for the moratorium no longer exists.
- C. This moratorium shall apply to all zoning districts and all real property within the Town.
- D. Pursuant to this moratorium, the Planning Board shall not review any applications for kennels nor shall it grant any preliminary or final approval to any special use permit, site plan or subdivision application which includes a kennel as part of the application.
- E. Pursuant to this moratorium, the Building Inspector shall not issue Building Permits or Certificates of Occupancy that involve the establishment, placement, relocation, construction, reconstruction, enlargement, modification or erection of any kennel.
- F. Pursuant to this moratorium, the Zoning Board shall not grant any approvals for any variance that involves the establishment, placement, relocation, construction, reconstruction, enlargement, modification or erection of any kennel.

Section 4. VARIANCE

- A. Any property owner affected by this moratorium may apply to the zoning board of appeals and make use of existing variance procedures under the zoning laws of the Town of Starkey.
- B. Current permitted kennels may apply to the planning board for approval of projects that improve the welfare of the animals.
- C. Current approved projects may be completed, and a certificate of occupancy issued.
- D. Each approved modification will be inspected by the Building Inspector to ensure compliance.

Section 5. PENALTIES

Any person, firm, corporation or other legal entity which shall establish, place, relocate, construct, reconstruct, enlarge, modify or erect any kennel in violation of the provisions of this Local Law, shall be subject to:

A fine not exceeding \$250.00 or by sentence of imprisonment not exceeding fifteen (15) days or by both. Each week of non-conformity can constitute a separate violation. (pg 56 section 7.51 of the Starkey zoning law)

B. Injunctive relief in favor of the Town to cease any and all such actions which conflict with this Local Law and, if necessary, to remove any construction, improvements, or related items or byproducts which may have taken place in violation of this Local Law; or

C. Any other remedy allowed by law.

Section 6. ENFORCEMENT

It shall be the duty of the Building Inspector to enforce the provisions of this Local Law. Section 7. VALIDITY

If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

Section 8. EFFECTIVE DATE

This Local Law shall take effect immediately upon filing with the New York State Department of State and shall remain in force and effect for a period of one (1) year from the date of such filing.
